- Each RSU represents the right to receive one share of common stock of Viatis Inc. (Viatis). 7,195 of the RSUs granted on March 2, 2021 vested on March 2, 2022 and 7,195 will vest on each of March 2, 2023 and March 2, 2024.
- Represents dividend equivalent units that accrued with respect to the RSUs previously granted on March 2, 2021 and vest on the same schedule as the underlying RSUs.
- Each RSU represents the right to receive one share of common stock of Viatis. The RSUs vest in three equal annual installments beginning on March 4, 2023.
